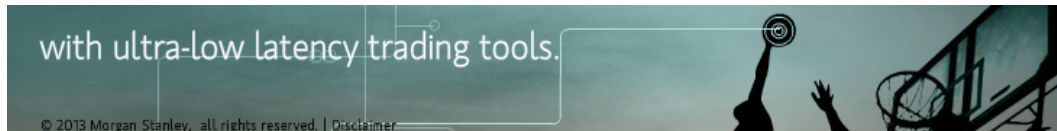

Once the branches gain enough membership and support, they will be self-sustaining entities and eventually fall under a STA LatAm division. But for now, STA Florida is at the vanguard of the initiative, Toes said, and those wanting to trade in Latin America will be directed to the Florida office.

The LatAm Committee is captained by STA Governor, Peter Stark and Chaired by Alan Gandelman, chief executive of ATS Brasil, a recently launched exchange owned by NYSE Euronext and Americas Trading Group, will work together with STA Florida in assisting in the overall build-out of a LatAm strategy. Victor Rodriguez will serve on the STA National Board as advisor to LatAm.

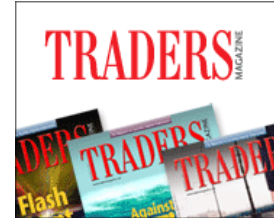
